Road Conversion from one-way to two-way traffic Kane Avenue from Kersdale Ave. to Dunraven Dr.

Contract: 21ECS-LU-01TT

Start Date: August 8, 2023 End Date: April 2024

*Timeline is subject to change.

The City of Toronto is working on the construction of a new storm sewer system that will collect, store and move stormwater (rain and melted snow) from the Fairbank-Silverthorn area to Black Creek. This work is part of the City's Basement Flooding Protection Program to help reduce the risk of future basement flooding. Once complete, the new storm sewer system will help to reduce the impact of heavy rainfall and sewer back-ups for more than 4,600 homes in your area.

The storm trunk tunnel and connecting storm sewers will be constructed using a tunneling method. Tunneling shafts are required at several locations to connect local storm sewers to the large diameter storm trunk tunnel. The City's contractor is constructing one of these shafts at the intersection of Dunraven Dr. and Scott Rd. To assist with moving traffic within this neighbourhood, Kane Ave. will be temporarily converted from one-way to two-way traffic.

Shaft Construction from August 8, 2023 to April 2024 (please see map on page 2):

- Kane Ave. between Kersdale Ave. and Dunraven Dr. will be converted from one-way southbound traffic to two-way northbound and southbound traffic.
- Scott Rd. between #60 and Aileen Ave. will be temporarily converted from one-way northbound to two-way traffic, only for local residents impacted by the closure.
- New stop signs will be installed at Dunraven Dr. and Aileen Ave. due to the temporary conversion.
- On-street parking will be restricted on Kane Ave. between Dunraven Dr. and Kersdale Ave. to facilitate this conversion.

These temporary measures will be lifted once construction at the intersection of Scott Road and Dunraven Drive has been completed. We anticipate this will be April 2024.

IMPORTANT INFORMATION ABOUT COVID-19 AND CONSTRUCTION WORK IN TORONTO


